



THE COOPERATION AGREEMENT
BETWEEN
HARBIN ENGINEERING UNIVERSITY
AND
FACULTY OF INTERNATIONAL STUDIES
PRINCE OF SONGKLA UNIVERISTY



Through a friendly discussion, Harbin Engineering University (hereafter called HEU) and the Faculty of International Studies, Prince of Songkla University, Phuket Campus (hereafter called FIS PSU) reach the following agreement of the FIS PSU's Study Abroad Program at HEU.

1. HEU will provide five (5) courses (as specified in the Addendum) for International Business students from FIS PSU, under the condition that there must be 10-15 students per course. Each course will award three (3) credits. The studying hours for each course will be 45 hours. The specific name of courses at HEU will be decided through discussion between the two universities before the start of each study program.
2. The duration of the study program will be around four (4) months (1 semester) starting in August of each year.
3. FIS PSU will pay 4,500 RMB per student for tuition and teaching material.
4. HEU will arrange on-campus accommodation with 2-4 people per room. The rate is 400 RMB per person per month, excluding the water and electricity costs (approximately 120 RMB per month).
5. Upon the arrival and leaving of PSU students and staff, HEU will arrange the pick-up and drop off service.
6. PSU Phuket students will pay a medical insurance fee of 400 RMB per person, which will cover the duration of their study at HEU.
7. This agreement shall be effective for five (5) years (2025–2029) from the date it is signed by both parties and is renewable, subject to an annual performance review. Termination requires a written notice from either party at least one month in advance.

8. Any other issues not mentioned here will be agreed through friendly discussion between HEU and PSU.
