



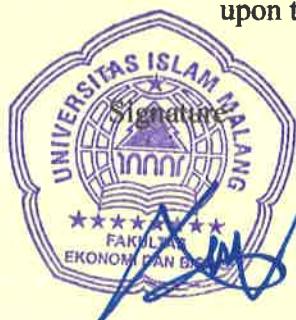
**MEMORANDUM OF AGREEMENT BETWEEN
FACULTY OF ECONOMICS AND BUSINESS
UNIVERSITAS ISLAM MALANG
AND
FACULTY OF INTERNATIONAL STUDIES
PRINCE OF SONGKLA UNIVERSITY
PHUKET CAMPUS**



The Faculty of International Studies (FIS), Prince of Songkla University, Phuket Campus (PSU Phuket), and the Faculty of Economics and Business, Universitas Islam Malang (FEB UNISMA), share a strong conviction that mutual agreement amongst people can be promoted through the establishment of connections between educational institutions, their scholars, students, and personnel. Therefore, through this Memorandum of Agreement (MoA) both institutions agree to the following:

1. FEB UNISMA will accept approximately 15 students into FEB UNISMA to study three (3) courses, each course awarding three (3) credits. The studying hours for each course will be 45 hours. The specific name of courses at FEB UNISMA will be decided through discussions between the two institutions before the start of each study program.
2. FIS will accept approximately 30 students into PSU Phuket to study two (2) courses and a community service program, each course awarding three (3) credits. The studying hours for each course will be 45 hours. The specific name of courses at FIS will be decided through discussions between the two institutions before each study program.
3. The duration of the study program for the FIS students will be around 60 days, starting early May each year, and for the FEB UNISMA students will be around 30 days, starting from August each year.
4. Both institutions will waive all tuition and fees for teaching material and activities for all participating students.
5. FEB UNISMA and FIS will arrange the on-campus accommodation for participating students with no charge from both institutions.
6. Upon the arrival and departure of FIS students and staff, FEB UNISMA will arrange the pickup and drop-off service. Similarly, upon the arrival and departure of FEB UNISMA students and staff, FIS will arrange the pickup and drop off service.
7. FIS students are responsible for their own medical insurance, which will cover the duration of their study at FEB UNISMA.
8. FEB UNISMA students are responsible for their own medical insurance, which will cover the duration of their study at FIS, PSU Phuket.
9. This agreement is valid for one (1) year from the date signed by both parties, and is renewable, subject to the annual performance review. If either party intends to terminate the agreement, a written termination notice shall be issued one (1) month in advance.

10. Any other issues not mentioned in this Memorandum of Agreement will be agreed upon through friendly discussions between FEB UNISMA and FIS, PSU Phuket.
